That this House notes the lack of a sufficient and comprehensive Government plan to decarbonise the UK economy in response to the climate and nature emergencies; recognises public support for bolder and faster action; and calls on the Government to support the Green New Deal Bill, formally known as the Decarbonisation and Economic Strategy Bill, which will introduce legally binding targets in line with the UK's commitment to stay within 1.5 degrees of global heating, reverse inequality, protect and restore nature and the environment, implement new measures of progress that prioritise human and ecological wellbeing in line with the recommendations of the Treasury-commissioned Dasgupta Review, change the way Government manages the economy to enable unprecedented investment in the Green New Deal, end investment in fossil fuels and establish a comprehensive action plan to transform the UK's energy supply, transport system, farming, land management, homes, buildings, green spaces and the way of working, creating millions of good green jobs across the UK, involve communities, trade unions and workers in the development of the plan, ensuring a just transition by prioritising investment in communities excluded from full participation in the economy and those working in today's high-emissions sectors, enhance the democratic power and resources of devolved governments, local authorities and elected mayors, increase democratic ownership in key sectors including energy, water, transport and mail and advance global justice by ensuring finance and technology for the global South and by promoting the Green New Deal globally.

**545 DVLA waiting times**Tabled: **19/10/21** Signatories: **1****Sarah Olney**

That this House is dismayed by the growing backlog of licence applications at the Driver and Vehicle Licensing Agency; recognises that the ability to drive is vital to many people's capacity to work and pursue the life of their choice; understands that the pandemic has caused unprecedented disruptions to the work of the DVLA; notes that over 125,000 paper licence applications are waiting to be processed, while 1.4 million items of correspondence by post remain unopened; further notes the sharp increase in the size of the backlog since the beginning of the pandemic; acknowledges that licence and licence renewal applicants are currently facing processing delays of up to 10 weeks; highlights with concern the unique burden placed on those with medical conditions who require their medical forms to be physically processed, whose processing times are up to six months; calls upon the Government to mobilise the resources necessary to clear the backlog at the DVLA, and supports the return of reliable, efficient, and covid-safe services to all British drivers.

That this House recognises the passing of Jakob Strandheim, the last surviving crew member of the Shetland Bus operations during the Second World War; notes that the Shetland Bus operations comprised almost 200 missions, transporting hundreds of refugees out of occupied Norway to Shetland and moving agents, supplies and equipment into Norway to support resistance actions; further acknowledges that such resistance operations may have kept as many as 350,000 Axis troops diverted during the War, providing invaluable benefit to the Allied cause; and further recognises that with Jakob's passing, there is a still-greater need to commemorate and learn from the events of the War as it passes from living memory.

That this House acknowledges the work and dedication of staff employed across the Medicines and Healthcare products Regulatory Agency (MHRA); notes that the agency plays a leading role in protecting and improving public health and supports innovations through research and development; is aware that the MHRA has three centres employing almost 1,200 staff and has numerous vital responsibilities across the health sector, including the approval and safety standards of medicines, medical devices and blood components for transfusions; applauds the tireless efforts of the staff during the covid-19 pandemic to ensure the swift approval and distribution of covid-19 vaccines, test kits and ventilators, protecting millions of lives across the UK; is alarmed to learn that the MHRA is now facing staffing reductions of up to 20 per cent despite a greatly increased workload as a result of the UK leaving the EU and the covid-19 pandemic; is concerned that fewer staff will be asked to cover more ground with fewer resources whilst operating under a pay freeze; is further concerned that any loss of expertise in this agency will lead to poor and potentially unsafe decision-making in a highly specialised field; is particularly worried about the impact of the loss of the National Institute for Biological Standards and Control, which is well-renowned as a distinct centre of excellence; and calls on the Government to intervene immediately to ensure jobs are retained and a properly funded MHRA can continue with its world-leading work in this field.

That this House notes the fashion industry's significant contribution to global plastic pollution; recognises that some 60 per cent of material made into clothing is plastic, with more than a third of all microplastics released into the ocean deriving from these synthetic fibres; further notes that some 70 million barrels of oil are used each year to make polyester; further recognises that a single clothes wash flushes an average of nine million microfibrils into our oceans; is concerned at a recent survey which found that 72 per cent of the UK public were not aware of the amount of plastic used to make clothing, and 66 per cent were not aware of clothing's impact on plastic pollution; backs campaign group A Plastic Planet's calls for transparency in the fashion industry on its use of plastic; believes that clear labelling is necessary to empower the public to make informed choices on whether to buy clothing based on its environmental impact; recognises that some 81 per cent of the UK public would like the Government to make it mandatory for brands to introduce a label that clearly shows if plastic is present in clothing and accessories; and calls on the Government to introduce this labelling system.

That this House recalls, fifty years on, the dreadful events of 21 October 1971, when Scotland's worst peace-time explosion ripped through the Clarkston Toll shopping precinct, quickly reducing the shops to rubble; recognises the devastating impact on the local community, with 22 people losing their lives and more than 100 injured, and the grief this caused for so many families across Clarkston, East Renfrewshire and beyond; further recognises that the majority of the victims were women and that minimal compensation was paid to victims or the families of the deceased; expresses concern that the cause of the explosion, which was likened to the detonation of a 300 lb bomb, has never been identified despite a fatal accident inquiry lasting 19 days, and that no one was held accountable for this tragedy, despite the fact that in the days before the explosion shop workers had raised concerns about the smell of gas, and, despite no source being found, the all-clear was given to open the shops on the morning of 21 October; records its appreciation of the work of the emergency services, with firefighters and police officers, aided by volunteers, working to recover people from the debris, while doctors, nurses and a fleet of 22 ambulances battled to save as many as they could; commends those in the local community who have worked to commemorate the victims of this dreadful event, the losses from which are felt to this day; and notes that the community in Clarkston will never forget.

This House is dismayed by Horsham District Council's proposed allocation of the Buck Barn site for a new development in its local plan which means that a planned Nature Recovery Area, linking the Knepp Estate with coastal and forest habitats, including St. Leonard's Forest and Ashdown Forest, to create a cross-Sussex wildlife corridor will be severely disrupted; notes that the Knepp Estate was cited as an outstanding example of nature regeneration in the 25 Year Environment Plan; further notes that that 25 Year Environment Plan proposed the creation of Nature Recovery Areas and that the Environment Bill requires the development of Local Nature Recovery Strategies; highlights the contradiction between environmental and planning policies that will hinder the creation of a cross-Sussex Nature Recovery Area; further notes that Buck Barn has been identified by Sussex Wildlife Trust as a site of high strategic value for Horsham District Council's own nature recovery network plan; urges Horsham District Council to reverse its decision to allocate Buck Barn for development; recognises that nature is in decline across the country and that our future prosperity, security, health and wellbeing depend on reversing that decline; further recognises that the recovery of nature can only be achieved if planning policies align with environmental policies and further climate and nature goals; and calls on the Government to use the forthcoming Environment Bill and Planning Bill to achieve that alignment, ensuring that the planning system delineates nature recovery networks and protects nature-rich spaces.
