1 **Speaker's Statement: Letter from the Speaker of the Ukrainian Parliament**

The Speaker informed the House that he had received the following communication from the Speaker of the Ukrainian Parliament:

On behalf of the Verkhovna Rada of Ukraine, I express my sincere gratitude to you and the House of Commons for your strong position in support of Ukraine, condemning the unprovoked and unjustified military aggression of the Russian Federation against the Ukrainian State.

The constant presence of the Ukrainian issue on the agenda of the House of Commons helps to draw the attention of British politicians and the public to the heroic resistance of the Ukrainian people. By defending their land, Ukrainians protect the common European ideals of freedom, democracy and peaceful coexistence.

I am sincerely grateful to you for organizing the Address of the President of Ukraine Volodymyr Zelenskyy to the Parliament of the United Kingdom, which has become a milestone event in the history of our bilateral relations.

Hoping for an end to the war as soon as possible and for the recovery of intensity of our interparliamentary contacts, I wish you, Mr. Speaker, inspiration and success in your responsible work.
