# **New EDMs**

205 BBC Digital First proposals and effect on journalists

That this House recognises the financial pressures faced by the BBC as a result of the freeze in the level of the Licence Fee but shares the concern of the National Union of Journalists regarding the likely impact of the BBC's digital first proposals on the breadth and quality of the Corporation's journalistic content and programming; welcomes the stated commitment to enhance investigative journalism across England, but regrets that the plans involve scrapping We are England, the successor to the award-winning Inside Out programme which was only launched last year once again putting staff at the risk of redundancy; is further concerned by the proposals to replace the BBC News Channel and BBC World News with a single service, threatening its present comprehensive sources of unfolding news and diminishing the overall breath and diversity of UK news and sport broadcasted; opposes the decision to scrap the local news and politics bulletins based in Oxford and Cambridge respectively, depriving people of relevant coverage to their own local communities; fears that the proposals will result in an overall reduction in the headcount of journalists employed, and compromise the role of the BBC in informing and educating as well as entertaining British public; and calls on BBC management to respond constructively to concerns expressed during the consultation period and think again where clear opposition is expressed.

That this House remembers the life and achievements of Bruce Kent whilst mourning his passing; notes that Bruce Kent was a peace campaigner who served as a Vice-President of the Campaign for Nuclear Disarmament, a Vice-President of Pax Christi, and Emeritus President of the Movement for the Abolition of War; notes that after national service in the Royal Tank Regiment and receiving a law degree at Brasenose College, Oxford, he was then ordained a Catholic priest for the Diocese of Westminster; further notes that it was his Christian faith that brought him to reject nuclear weapons as fundamentally immoral; highlights that even without their use, nuclear deterrence itself depends on a willingness to commit mass murder; recognises that Bruce Kent served as general secretary and then chair of CND in the 1980s and that his leadership was the embodiment of integrity, creativity and sheer determination, becoming a vocal critic of defence policy when public opposition to the acquisition of Trident and cruise missiles was escalating; further recognises that his commitment to innumerable peace and human rights campaigns over many decades was inspirational to many; and extends its deepest sympathies to the family of Bruce Kent and his friends

That this House celebrates the tireless efforts of countless individuals and organisations, especially community groups, schools, emergency services and road safety professionals, to champion road safety and reduce deaths and serious injuries affecting the young on roads; highlights the 10,125 young people, under the age of 16, killed, seriously injured or slightly injured on roads in the UK in 2020, including 644 in Northern Ireland, despite the covid-19 outbreak reducing traffic and the fact that no level of casualties is acceptable; welcomes £2 billion investment into active travel schemes; congratulates Brake's Kids Walk on 22 June 2022 as a focus of community efforts to raise awareness;

notes that over 90,000 schoolchildren from over 600 schools will be speaking out about road safety

and the steps that can be taken to stop these avoidable tragedies affecting some of the most vulnerable in communities; further notes that on average six children are killed or seriously injured on UK roads every day; reiterates the WHO's findings that deaths from road traffic injuries are the single biggest killer of children and young people aged five to 29 globally and that exposure to air pollution, inclusive of vehicle emissions, is seriously damaging children's health; supports Brake's continuous drive to push for safer road journeys enabling children to walk in their community without fear of traffic and pollution; and urges the Government to implement statutory guidance for teaching road safety in UK schools so children can understand road danger and learn more.
