#### 357 Achievements of Daniel Cornet

That this House praises Dunfermline's Daniel Cornet on winning gold in mini tennis at the British Transplant Games; notes that Daniel accomplished this just one week after leaving hospital following a major operation; commends Daniel for the strength and resilience he has shown since he was diagnosed with end stage renal failure shortly after being born; encourages others going through a similar experience to take inspiration from Daniel to never give up; and wishes Daniel and his family all the best for the future.

#### 358 Heriot-Watt University bicentenary 1821 Appeal

**359 International Clean Air Day 2022 and car manufacturers**

That this House celebrates International Clean Air Day 2022 on Wednesday 7 September; acknowledges that air pollution is the largest environmental risk to public health in the UK, accounting for as many as 64,000 premature deaths each year; expresses deep concern over reports that the emissions scandal has resulted in an extra 10.2 million vehicles worth of emissions in the UK; criticises the failure of car manufacturers previously found to have cheated emissions rules to take action in the UK to address both the environmental and human health impact of their conduct; recognises that these car manufacturers celebrated a combined total of nearly £220 billion in second-quarter earnings alone; urges car manufacturers to stop putting profit ahead of public health and take immediate action to reduce emissions through hardware retrofits and compensate affected owners; further notes that in Germany hardware retrofits for 60 separate diesel models have reduced nitrogen dioxide emissions by 60-95%; and calls on the Government to take decisive action against car manufacturers to reduce levels of toxic air pollution.

**360 Belhaven Brewery**

That this House congratulates Belhaven Brewery, Scotland's oldest working brewery, on receiving three awards for its visitor centre and its Scottish Oat Stout at the World Beer Awards; understands that the visitor centre won the highly coveted Visitor Attraction of the Year title in the competition's inaugural Icons of Beer sector, and that Belhaven's Scottish Old Stout was crowned the World's Best Oatmeal Stout after winning the UK's Best Oat Stout in August; notes that the visitor centre underwent a multi-million-pound refurbishment last year before being officially opened by Paralympic medal winner Maria Lyle; and acknowledges that Belhaven Brewery was established in 1719 and is known today as The Home of Scottish Brewing and produces more than three hundred types of premium beers and ales.

That this House notes with concern the impact of Brexit on inflation; notes research by the UK in a Changing Europe think tank revealed that Brexit has increased food prices by 6 per cent; acknowledges that sterling has lost 10 per cent of its value, leaving households poor by increasing import costs and inflation while lowering wage growth; is aware of research published by the London School of Economics and Resolution Foundation that Brexit has reduced how open and competitive Britain is, leading to reduced productivity and wages over the next decade; recognises that the Office for Budget Responsibility says Brexit will have the long-term effect of cutting GDP by 4 per cent; understands that the Financial Times agreed that such a decline will mean £100 billion of lost output and £40 billion less revenue for the Treasury each year; is concerned that the UK has now fallen behind all other G7 countries in the pace of its recovery from the covid-19 pandemic, with exports down significantly and believes that Scotland will prosper more by regaining its independence and rejoining the EU than by remaining in the UK.

That this House is very concerned about the intensified human rights crackdown in Saudi Arabia, including against women; is shocked by the 34-year sentence handed down to Leeds University PhD student Salma al-Shehab for tweets, the 45-year sentence handed down to Nourah al-Qahtani also over her social media activity, and video footage purportedly showing women at an orphanage in Khamis Mushait protesting poor living conditions being attacked by security forces; is dismayed by reports that 120 individuals have been executed in Saudi Arabia in the first six months of this year, with dozens put to death for their participation in pro-democracy demonstrations; believes that the reform programme publicised by the de facto ruler of the Saudi Kingdom Crown Prince Mohammed Bin Salman will only be credible if it mandates compliance with international human

rights law and standards; urges the Saudi Government to end the abuse and unwarranted prosecution of individuals in Saudi Arabia exercising their fundamental rights, including freedom of expression, association, assembly and belief; calls on the Government to publicly express their concern about these cases and the need for the immediate release of all peaceful activists, critics and demonstrators in Saudi Arabia.

That this House notes with alarm data released by the Office for National Statistics on 3 August 2022 showing that a record 4,859 deaths related to drug poisoning were registered in England and Wales in 2021; further notes with alarm figures published by National Records of Scotland on 28 July 2022 revealing that 1,330 people lost their lives to drug misuse in Scotland in 2021, higher than any European country; recognises and reaffirms that people struggling with an alcohol or drug problem should get the same support and treatment as those with any other health condition; acknowledges that stigma stops many people accessing the assistance and resources they require; applauds initiatives such as the Stigma Kills awareness campaign, launched by the NHS Addictions Provider Alliance, and The Reporting of Substance Media Toolkit resource for journalists and editors looking to report on alcohol and drugs with dignity and respect, created by Scottish Families Affected by Alcohol and Drugs and Adfam; and calls on the Government to support the efforts of those challenging stigma, removing barriers to treatment and reducing the devastating level of drug deaths across the UK.

That this House recognises the tragic impact that miscarriages of justice have on victims, their family and friends; notes that the legal doctrine of Joint Enterprise has been prone to erroneous use through the misapplication of Parasitic Accessorial Liability before 2016 as identified by the Supreme Court in the case of R v Jogee (2016) UKSC 8; acknowledges that avenues for appeal are limited for those convicted with only two out of 103 appeals made with reference to the 2016 judgement having been successful; recognises that this is because of uncertain interpretation and multiple common law judgements that have resulted in a strict set of requirements for an appeal to succeed; is extremely concerned that the limited access to appeals is resulting in miscarriages of justice and that a new avenue for appeals is necessary; and calls on Members to support the Criminal Appeal (Amendment) Bill on Tuesday 6 September 2022 which would give leave to appeal an unspent conviction when there has been a material change to the law.

That this House regrets the avoidable harm caused by the use of surgical mesh, Primodos and Sodium Valproate; acknowledges the need to support the hundreds of victims in the UK suffering as a result of these interventions; welcomes the recommendations made by Baroness Cumberlege in her 2020 report on the IMMDS Review; notes that recommendation 4 of this report calls for the establishment of separate schemes to meet the costs of additional care and support to those who have suffered avoidable harm; regrets that in the two years since the report's publication, the Government has refused to accept this recommendation; further regrets the suggestion that victims should pursue legal routes to compensation, which fails to recognise the adversarial nature and inaccessibility of litigation; and calls on the Government to establish separate schemes to provide financial redress to the victims of surgical mesh, sodium valproate and hormone pregnancy tests, as recommended by the Cumberlege report.
