Ian Byrne presented a Bill to require the Secretary of State to conduct a review of

the funding of hospices specialising in the care of children and to publish proposals for measures to guarantee access to hospices for all children who require palliative care; and for connected purposes.

4 Registration of Death (Religion) Bill: Presentation (Standing Order No. 57)

Preet Kaur Gill presented a Bill to make provision about the collection of religious information of the deceased where the death has been registered; to make provision for religious data to be provided on a voluntary basis; and for connected purposes.

Bill read the first time; to be read a second time on Friday 17 January 2025, and to be printed (Bill 116).

5 Firearms (3D Printing) Bill: Presentation (Standing Order No. 57)

Preet Kaur Gill presented a Bill to create an offence of possessing a blueprint for the

production of a firearm by 3D printing; to create an offence of possessing part of a firearm produced by 3D printing; and for connected purposes.

Bill read the first time; to be read a second time on Friday 17 January 2025, and to be printed (Bill 117).

6 Microplastic filters (washing machines): Motion for leave to bring in a Bill (Standing Order No. 23)

Ordered, That leave be given to bring in a Bill to require manufacturers to fit microplastic-catching filters to new domestic and commercial washing machines; to make provision about the promotion of the use of microplastic-catching filters in washing machines and raising awareness about the consequences of microplastics from washing machines for pollution in rivers and seas; and for connected purposes;

That Alberto Costa, Sarah Champion, Jim Shannon, Sir Julian Lewis, Ellie Chowns, Ruth Jones, Peter Dowd, Siân Berry, Carla Denyer and Mr Alistair Carmichael present the Bill.

Alberto Costa accordingly presented the Bill.

Bill read the first time; to be read a second time on Friday 7 March 2025, and to be printed (Bill 114).
