That this House, while recognising the economic damage caused by the previous Government, declines to give a Second Reading to the Finance Bill because it derives from a Budget that did not reverse the previous Government's cuts to the Bank Corporation Tax surcharge, raise the Digital Services Tax to 6% or double Remote Gaming Duty to 42% in order to fairly secure through taxation

the funding needed to end the crisis in social care, reverse cuts to the Winter Fuel Payment and support people with the cost of living; announced restrictions on inheritance tax relief for agricultural property, putting at risk food security, the natural environment and the heritage of local communities; proposed increases to the rate of alcohol duty that risk hurting consumers and businesses, including the wine and Scotch whisky sectors; introduced a tax on education by levying VAT on independent school fees, making things harder for 100,000 children with Special Educational Needs and Disabilities in private education without Education, Health and Care plans; and did not bring in fair reforms to the tax system to boost economic growth.

That this House declines to give the Finance Bill a Second Reading because it derives from the 2024 Autumn Budget which will lead to jobs being lost, curtailed investment and prices being raised; because the Finance Bill constitutes an assault on business by increasing taxes on investment; because it will reduce the competitiveness of the United Kingdom's tax regime; because it levies the first ever tax on educational choice and will increase pressure on state schools; because it will drive up rents by increasing tax on homeownership; because it will substantially increase the size of the state without a sustainable plan to fund it; and because it will reduce living standards, increase borrowing and debt, drive up inflation and interest rates, with the result that the OBR growth forecast for the Autumn Budget is lower than that accompanying the Spring Budget of the last Government.

That this House, recalling that United Nations Resolution 2758 of 25 October 1971, which established the People's Republic of China (PRC) as the only legitimate representative of China to the United Nations (UN), does not mention Taiwan, notes that UN Resolution 2758 does not address the political status of Taiwan or establish PRC sovereignty over Taiwan and is silent both on the status of Taiwan in the UN and on Taiwanese participation in UN agencies; and calls on the Government to clarify its position that UN Resolution 2758 does not establish the One China Principle as a matter of international law, to state clearly that nothing in law prevents the participation of Taiwan in international organisations and to condemn efforts made by representatives of the PRC to distort the meaning of UN Resolution 2758 in support of Beijing's One China Principle and the alteration of historic documents by representatives of the PRC, changing the name of the country from Taiwan to Taiwan, province of China.

That this House declines to give a Second Reading to the Terminally Ill Adults (End of Life) Bill because the House's procedures for the consideration of Private Members' Bills do not allow for sufficient debate on and scrutiny of a Bill on a matter of this importance; recognises the importance of having a fully-informed debate and vote on assisted dying, which should be subsequent to an independent review of and public consultation on the existing law and proposals for change; and considers that the review and consultation should be informed by an independent assessment of the provision of palliative care for adults who are terminally ill.
