Title accordingly amended, as follows:

A Bill to make provision in relation to domestic abuse; to make provision for and in connection with the establishment of a Domestic Abuse Commissioner; to make

provision for the granting of measures to assist individuals in certain circumstances to give evidence or otherwise participate in civil proceedings; to prohibit cross-examination in person in family or civil proceedings in certain circumstances; to make further provision about orders under section 91(14) of the Children Act 1989; to provide for an offence of threatening to disclose private sexual photographs and films with intent to cause distress; to provide for an offence of strangulation or suffocation; to make provision about circumstances in which consent to the infliction of harm is not a defence in proceedings for certain violent offences; to make provision about certain violent or sexual offences, and offences involving other abusive behaviour, committed outside the United Kingdom; and for connected purposes.

Motion made and Question put forthwith (Standing Order No. 83H(2)), That a Committee be appointed to draw up Reasons to be assigned to the Lords for disagreeing to their Amendments 1 to 3, 9, 33, 37, 38, 40, 41, 43 and 83 to the Domestic Abuse Bill.

That Victoria Atkins, Chris Elmore, Tom Pursglove and Michael Tomlinson be members of the Committee.

That Victoria Atkins be the Chair of the Committee.

That three be the quorum of the Committee.

That the Committee do withdraw immediately.—(*Michael Tomlinson.*)

## **7 Domestic Abuse Bill (Reasons Committee)**

Victoria Atkins (Chair) reported that the Committee had agreed the following Reasons:

## Lords Amendments 1 to 3

Because it is inappropriate to extend the definition of “domestic abuse” in the Bill to include abuse carried out against a disabled person by the person’s carer.

## Lords Amendment 9

Because it is unnecessary to provide for the accreditation of child contact centres by local authorities.

## Lords Amendment 33

Because it is unnecessary and is contrary to the principle of judicial independence.

## Lords Amendment 37

Because it is inappropriate to extend the so-called ‘householder defence’ to victims of domestic abuse who use disproportionate force against their abusers in self-defence.

## Lords Amendments 38 and 83

Because it is inappropriate to provide a new defence for victims of domestic abuse who are compelled to commit an offence as a result of such abuse, as the existing common law defence of duress is sufficient.

## Lords Amendment 40

Because the Government has committed to reviewing the processing of migrant victims' personal data for the purposes of immigration control in response to the report on Liberty and Southall Black Sisters' super-complaint on policing and immigration status published by Her Majesty's Chief Inspector of Constabulary on 17 December 2020, and the Commons consider that the Amendment would preempt the outcome of that review.

## Lords Amendments 41 and 43

Because the Amendments would involve a charge on public funds, and the Commons do not offer any further Reason, trusting that this Reason may be deemed sufficient.

The Reasons were agreed to.
